

#### **Design Development**


- Staff met with the Monterey Peninsula Unified School District (District) on four separate coordination meetings to determine a safety plan for Ord Terrace Elementary School.
- City immediate improvements include:
  - Restriping crosswalk and pavement markings
  - Reduced speed limits signs within the school zone on La Salle and Ord Grove Avenues
- District improvements include creating a student drop off area, and bus loading zone, in addition to on-site improvements to be constructed starting in the summer.
- Presented to TAC on March 21, 2023



#### City Improvements


- 1. Offset Crosswalk with rapid flashing beacons
- 2. Refuge island
- 3. Curb extension/bulb out
- 4. Centerline flexible delineators east & west of Lindberg Court
- 5. Sidewalk improvements west of parking lot
- 6. New striping and signage

- Coastal Paving and Excavation Inc.

#### Recommendation
